This year we welcome Croatia into the World Council credit union family. We invite you to learn more about this unique country, located in the northwestern part of the Balkan Peninsula. Croatia is a small yet geographically diverse country with natural beauty and a pleasant climate.

Saturday, May 16: Depart the U.S. and travel to Zagreb. Booking airline tickets and airport transfers is your responsibility and depending where you are flying from you may have to depart a day earlier than arrival. Burkhalter Travel is happy to assit you with booking your air and airport transfers. please just let us know.

Sunday, May 17: Arrive in Zagreb. Upon arrival you will transfer to the Sheraton Zagreb Hotel. You will have a pre-dinner orientation briefing on Coratia and Zagreb and will have dinner at the hotel. (D)

Monday, May 18: After breakfast you will have a World Council, Croatian and European Credit Union overview at the hotel (including refreshments/tea/coffee). Then you will have lunch and a Cultural Exploration of Zagreb's Old Town. (B/L/D)

Tuesday, May 19: After breakfast World Council hosts a European cooperative banking session with refreshments/tea/coffee at the hotel. At 10:30 you will take a motorcoach to Split and on the way you will have lunch and visit Plitvice Lakes. You will check into Radisson Blu Resort in Split that evening and have dinner at the hotel. (B/L/D)

Wednesday, May 20: After breakfast, you will have a site visit to Split credit unions. Then you will have lunch and a cultural tour of Split including Old Town. After the tour you will have a learning session with the European Network of Credit Unions and Regional Credit Union Center. (B/L/D)

Thursday, May 21: After breakfast join World Council and learn about the Polish and Ukrainian credit union systems. At noon you will take a motorcoach to Dubrovnik and enjoy a box lunch. After check into Sheraton Dubrovnik Riviera Hotel and you will have a pre-dinner Cultural Walking Tour of the Old Town. (B/L/D)

Friday, May 22: After breakfast, you will have a walking tour of Dubrovnik and experience Italian, Hungarian, Austrian and Balkan cultures. After lunch you will take a boat trip around the city walls and have dinner at a local restaurant. (B/L/D)

Saturday, May 23: This day is free with lunch on your own and a World Council "farewell" dinner tonight. (B, D) **Sunday, May 24:** After breakfast, check-out and transfer to Dubrovnik airport for departure. (B)

TOUR TERMS AND CONDITIONS - PLEASE READ CAREFULLY

I.D./Citizenship: US Travelers must possess a passport valid for at least six months beyond the tour dates with names matching those on their tour and flight reservations. Complete name, gender and birth date are required to confirm reservations per TSA/airline requirements. Non-US travelers please check with your country's travel requirements to Croatia.

Deposits and Payments: The online registration form must be filled out at time of booking and a credit card is required to secure reservations. Full payment is due at time of booking.

Cancellations/Refunds: This tour is based on a minimum of 15 passengers traveling together. In the rare instance that there are not enough travelers, Burkhalter Travel may have to cancel the tour in which case you will receive a full refund for the land package, otherwise tour cancellation penalties are as follows:

Prior to February 1, 2020—\$500 penalty After February 1, 2020—Non refundable

No refund will apply on unused portions of the tour. Once issued, airline tickets are 100% non-refundable. Name changes and departure date changes are subject to penalties per the airlines policy.

Travel insurance: We strongly recommend the purchase of travel insurance to protect your investment. Coverage for trip cancellation, interruption, delay and medical emergency is available. Ask your travel agent for details.

Tour Conditions: All arrangements are based upon tariffs in effect 10/1/2019 and are subject to change. Once deposit has been received, any changes to air or land arrangements may be assessed a revision fee between \$50-\$250. Revision fees may be higher once air is ticketed.

Air Transportation: Burkhalter Travel is happy to assist you with your airline reservations. Once ticketed airfares are non refundable and there are penalties to make changes. Burkhalter Travel can also assist with airport transfers.

Accommodations: Though we are using well known hotel chains, hotel rooms in Europe are often smaller than American hotels, and many rooms will have twin beds. Single rooms can sometimes be even smaller and may have just one twin bed. Hotels are subject to change.

Traveler Fitness: Travelers should be in reasonably good health, able to board a motorcoach in a timely manner, climb stairs and walk moderate distances over sometimes uneven ground. Individuals with physical and/or cognitive limitations must be accompanied by an able individual who will assume complete responsibility for them. Tour personnel and hosts cannot and will not provide this kind of assistance.

Passenger Consent Agreement: Department of Transportation regulations require that we inform you that your purchase is subject to supplemental price increases beyond our control that may be imposed after the date of purchase.
